Prevent Policy

April 2022

All schools have a duty to support the Counter-Terrorism and Security Act 2015 and have due regard to the need to prevent people from being drawn into terrorism. This guidance is designed to aid schools to be able to think about how they can protect children from the risk of radicalisation and have an awareness of the services that are available to support their concerns.

As a school we forbid political indoctrination in any form and work to ensure that our pupils have a balanced presentation of political issues. We actively promote spiritual, moral, social and cultural development of our pupils and, within this, British values.

At Highgate Primary School we are actively implementing the Prevent duty in the following ways:

Curriculum

Pupils are taught about the diverse national, regional, religious and ethnic identities in the UK and the importance of mutual respect and understanding. Our Curriculum celebrates and reflects the diverse community that we are fortunate to have at our school. The school achieves this through a wide range of ways which are regularly evaluated.

ICT

We have in place a robust filtering system that ensures that terrorist and extremist material is not accessible via the internet at school. We teach children the wider dangers of the internet and equip them with the knowledge to stay safe online both at home and school.

PSHE

Our fundamental school ethos is that everybody is valued equally and deserves respect. We pride ourselves on having a strong 'talking' culture where we are able to explore controversial issues in a safe environment. Our Personal, Social, Health and Economic Education (PSHE) builds on this idea in the following ways:

- Building resilience, self-esteem and confidence
- Encouraging children to make the right decisions, manage risk and make safer choices
- Encouraging debate and challenging ideas

Staff Responsibilities

The school ensures that all staff have a good understanding of the issues surrounding the Prevent agenda. It ensures this in a range of ways including:

- Named designated member of staff in school
- Named member of staff has attended Prevent Awareness training provided by Haringey LSCB
- All key staff have completed online Channel training
- Whole staff training on the Prevent duty and role of Channel
- Whole staff training on how to identify and protect children from the risk of radicalisation

Designated member of staff's responsibility

- Secure register of concerns held and referred, if appropriate, to the relevant professional organisation
- Knowledge of Counter-terrorism Local Policy (CTLPS) and base analysis of the local environment from the Metropolitan police
- Monitoring of after school provision and supplementary provision if concerns are held
- Carry out reasonable checks, for example for links with extremism, on all visitors who are intending to work with children, learners and/or staff
- Effective engagement with parents and a solid understanding of how to refer any parents with concerns to the relevant agency
